Preambulatory Clauses:

Preambulatory clauses must be underlined and not numbered

Condemns in the strongest possible terms the military actions perpetrated by the Russian Federation in Ukraine, which constitutes to a series of violations of international law and an unjustified aggression which undermines European security and stability,

Emphasizing the significance of an immediate ceasefire and the complete withdrawal of Russian forces from Ukraine, reinstating the full respect for the sovereignty and the territorial integrity of Ukraine,

Resolutely demands the Russian Federation to respect international law, lay down its arms and return to the path of diplomacy,

<u>Keeping in mind</u> that both NATO and Russia must agree that nuclear warfare can never be won, and must never be fought,

<u>Deeply concerned</u> by Russia's military strategies and policies overshadowing Europe's sovereignty and stability,

<u>Having devoted attention</u> to Ukraine's war efforts and Ukrainian's patriotic nature, defending their rightful territory and sovereignty,

Expressing appreciation to NATO and EU for assisting Ukraine in multitude of assistance via aid, | —>leave a line between every clause

Further deploring the need to step up efforts to promote diplomatic endeavors aimed at de-escalation and peacekeeping while seeking all possible necessary measure to reaffirm full respect to Ukraine's territorial integrity and sovereignty,——>All preambulatory clauses must end in commas (,)

<u>Bearing in mind</u> to provide the necessary financial and humanitarian assistance in coordination with the whole of international community, to Ukraine and to the Ukrainian people in response to humanitarian emergency and to remind Russia of its obligation to observe international humanitarian law,

<u>Fully believing</u> that irrespective of Russia's commitment to the Rome Statue or the International Criminal Courts treaty, justice for the multitude of war crimes committed by Russia will be delivered,

Clause opening statements should not be repeated in the resolution. If necessary add phrases such as "further", "extensively", "Strongly" before clause opening statements which were previously used

Operative Clauses:

- 1. <u>Calls upon</u> the North Atlantic Treaty Organization (NATO) and other willing nations to associate with bodies such as the United Nations Office on Drugs and Crime (UNODC) and United Nations Information Security Special Interest Group (UNISSIG) to establish mandate of cyberwarfare with compliance of traditional principles of war, while authorizing reforms within the legislature of Cooperative Cyber Defense Center of Excellence (CCDCOE) to:
 - a. Prevent the rise of cyberwarfare as a mean of destabilizing governments,
 - b. Improve cyber defense in NATO's defense supply chain,
 - c. Extensively incorporate cybersecurity requirements into the NATO defense planning process (NDPP),

- d. Immediately integrate cybersecurity in both military and civil emergency operational planning,
- e. Induce the use of "honey pot servers" to lure cyberattacks while both detecting and deflecting any counts of threat;
- 2. Emphasizes on the dire need for the establishment of an Ad- hoc tribunal under United Nations Security Council (UNSC) following the case study of International Crime Tribunal for Rwanda (ICTR) and International Crime Tribunal for Yugoslavia (ICTY) in order to hold Russian federation accountable under the wing of "crimes against peace" in international war crimes tribunal, irrespective of Russia's withdrawal from international Criminal Court treaty (ICC) under the cases of:
 - a. The illegality of aggressive war as opposed to defensive war in international law under the 1945 United Nations Charter,
 - b. Violating the norms of both third and fourth Geneva convention and protocols,
 - c. The attack and seizure of the Chernobyl and Zaporizhzhia
 powerplants which violates both the treaty of the non –
 proliferation of nuclear weapons and the international convention
 for the suppression of acts of nuclear terrorism,
 - d. The use of phosphorus munitions and incendiary bombs used by the Russian military which violates the conventions on certain conventional weapons and chemical weapons convention,
 - e. Violation of the Hague convention for the protections of cultural property in the event of armed conflict exists in which 53 United Nations Educational, Scientific and Cultural Organization (UNESCO) sites in Ukraine were destroyed by Russian targeted missiles;

3. <u>Appeals</u> for the formation of "NATO BANK "under legislative approval and regulation from UNSC / NATO under transparency and other key factors, while recommends for all willing and able NATO/ European Union (EU) member states and non-member countries in the Euro – Atlantic zone to address the need to increase funding towards the "Geneva Centre for security policy", "NATO/Partnership for Peace Program (PFP) and "NATO

All acronyms must be fully written out before being displayed in the abbreviated form Write the full form once and refer to the abbreviated form for the rest of the resolution

Support and Procurement Agency (NSPA) trust fund, through the NATO bank as:

- a. The NATO bank would prioritize on allied defense budget while resembling other multilateral financial institutions thus breaking nations away from debt trapping done by China and Russia,
- b. Finance efforts would be implemented to address critical gaps that improves alliance,
- c. The bank would better equip the alliance to manage the financial challenges of conflict, such as food insecurity and humanitarian assistance in Ukraine;
- 4. <u>Suggests</u> the need for Economic and Social council (ECOSOC), and Global Crisis Response group on Food, Energy and Finance to regulate agenda in which all able and willing nations to assist these mandates in order to prioritize Ukraine conflict amidst:

sub clauses must be listed in alphabetical order

- a. Economical Warfare by Russia in which key exports of steel, grain and fertilizers are at halt, crumbling Ukraine's economy and war efforts,
- b. To keep trade flowing and minimize disruptions to supply chains,
- c. Calls for the immediate withdrawal of Russian Naval blockade from the three Black Sea ports in Odesa to boost humanitarian aid and trade flow;
- 5. <u>Further calls upon</u> for an immediate implementation of United nations fact finding mission while suggesting the member nations to support the nature of "Liechtenstein protocol" which aims to improve multilateralism and to create a decentralized compliance protocol for security token in UNSC in which under
 - a. Accordance to the of UN NATO joint declaration of 2008, following the 2007 UN EU joint declaration, the employment of UN -fact finding mission to address:

i. The legitimacy of Russia's seat in UNSC, acknowledging
the transfer of VETO power from USSR to Russia after the
dissolution of the Soviet Union in 1991,

Sub - sub clauses must be listed in Roman numerals (i, ii, ii, iii, iv, ...)

ii. The violations made by Russia and its contradictory stance with article 6 of the union charter which states "A member of the United Nations, which has persistently violated the principles contained in the present charter, may be expelled from the organization by the General Assembly upon the recommendation of the Security Council",

iii. The promotion of mechanism abiding all UNSC regulations in which Russia's VETO vote would be momentarily blocked-in which Russia is a side to the conflict;

- 6. <u>Designates</u> existing conventions within NATO ranging from Partnership for peace program, Euro Atlantic partnership council and others, superintended by UNSC to be used as a platform to:
 - a. Endorse direct talks with Kremlin and Ukraine representatives on the account of ceasefire agreements which ensures complete withdrawal of Russian troops from Ukraine soil and the complete restoration of Ukraine's territorial integrity and sovereignty,

b. Addresses Russia's growing military presence in Baltic states which threatens national security of Eastern Europe,

- c. Ensures the sovereign right of nations in Euro-Atlantic zone to uptake their decision of joining NATO through the open-door policy or any other alliance they aspire;
- 7. <u>Further requests</u> reforms within the mandate and legislature of NATO, Partnership for peace program (PFP), Euro Atlantic Partnership council in order to:
 - a. Promote NATO expansion by amending article 10 which allows for the invitation of "other European states" only,
 - Facilitating the expansion of member states out of the post –
 soviet / cold war frame with special emphasis on PFP,

- c. Signify the commitments presented within the framework document and its annexures,
- d. Explicate the concepts under the norms of "intervention" and "non- intervention";
- 8. <u>Draws attention</u> towards the articles of Helsinki accords and Ottawa convention with special emphasis on Russia's growing military presence and aggression towards Baltic nations which facilitates:
 - a. Russian A2/AD bubbles in the Baltic Sea region,
 - b. Territorial security of Gotland and Bornholm,
 - c. Significance of Hultqvist doctrine and Finland's membership in NATO,
 - d. NATO deterrence and defense measures in Estonia, Lithuania, and other Baltic/Nordic states,
 - e. The support for EU's Common Security and Defense policy initiatives that complement NATO and are open to non-EU NATO members;

All operative clauses must end in semi colons (;) \checkmark

- 9. <u>Calls upon</u> the member states in light of worsening humanitarian crisis and mass movement of refugees to:
 - a. develop evidence gathering database which will be utilized to create profiles of refugees/IDP coming from Ukraine or any other parts of conflict by,
 - Gathering information via "Refugee
 Registration Offices" to register undocumented
 refugees similar to the program conducted by
 the BAFIA in Iran,
 - ii. Encouraging nations to provide prima facie recognition for refugees from countries in dire need of asylum particularly those facing war or natural disasters.
 - b. Utilize funding to the UN humanitarian response plan 2022, which was launched to facilitate humanitarian aid for Ukraine,

- c. Using initiatives such as the WFP under the UN and using existing NATO resources to cater food provisions,
- d. Improving the monitoring and regulation of refugee distribution to all willing and able NATO member nations to ensure the minimization of refugee backlogging via,
 - Using existing European private businesses in partnership with NATO to create channels of distribution and resettlement for refugee transports;
- 10 Further invites all willing and able Nations / Organizations to step up efforts in terms of providing and distributing aid for Ukraine, under the required scope of:
 - a. Medical supplies,
 - b. Military training/military equipment,
 - c. Ammunitions,
 - d. Surveillance/targeting/heavy lift operation drones,
 - e. Defense mechanisms: to assist Ukrainians, defend their rightful territorial/ political integrity and sovereignty.

A full stop (.) ends the last operative clause, indicating the end of the resolution

When writing preambulatory clauses -

- State strong and recent facts about the issue.
- Use statistics where applicable.
- Recall any passed resolutions by the UN on the issue.
- State relevant organization's action / involvement in the situation.
- Do not use phrases such as "Third World Countries" / "First World Countries" / "poor countries" / "rich countries".

When writing operative clauses -

- Aim to find solutions, which solve the fundamental of the issue.
- Elaborate on the solutions used in the clauses.
- Explain different methods of approaching the issue through the clauses.
- Do not be vague with solutions or do not simply state a way of solving the issue without explaining the ways of doing so.
